## Invitation to Bid for the “Project: Replacement of Dilapidated Transmission and Distribution Pipelines in Central Section”

1. The **TOLEDO CITY WATER DISTRICT (TCWD)**, intends to apply the sum of **Twenty Five Million Pesos (Php25,000,000.00)** the Approved Budget for the Contract (ABC) to payments under the contract for the **Project: Replacement of Dilapidated Transmission and Distribution Pipelines in Central Section under PR 2023-11-132**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **TCWD** now invites bids for the above Procurement Project. Completion of the Works is required *within 405 Calendar Days*. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from the BAC Secretariat and inspect the Bidding Documents at the address given below from *9:00am – 3:00pm Monday to Friday except on Holidays*.
5. A complete set of Bidding Documents may be acquired by interested bidders on *December 29, 2023* from given address. The Procuring Entity shall allow the bidder to present its proof of payment for the fees, *presented in person, by facsimile, or through electronic means*.
6. The **TCWD** will hold a Pre-Bid Conference<sup>1</sup> on *January 10, 2024 at the Conference Room, TCWD CIC Office Luray 2 Toledo City* which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below not later than *12:00pm on January 22, 2024*
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 16.
9. Bid opening shall be on *January 22, 2023 @ 1:30 pm* at the Conference Room, CIC Office Luray 2, Toledo City. Bids will be opened in the presence of the bidders’ representatives who choose to attend the activity.

The *TCWD reserves* the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
